Spainagrin, J.L., Dec. 23.—Gov. Oglesby has overfuled the action of the State Board of Health in revoking the license certificate of Dr. Henry G. Wildman, a Chicago physician. The license was revoked for alleged unprofessional conduct on the part of Wildman, who is an extensive advertiser in the newspapers. He is a graduate from a medical institute of good standing. The case was prosecuted before the Governor on appeal by ex-Gov. Hamilton, and has attracted a good deal of attention in the State as having an important bearing on the power of the Board of Health to prevent advertising on the part of physicians.
