Death of Greenbury B. Humphrey, a Former Lebanon Merchant-Was Honorable and Good-Hearted

Last week the Democrat noted briefly the death of Greenbury Humphrey, which occurred about 4 o'clock of the prezious Wednesday afternoon. Humphrey had been a merchant at Lebanon for 37 years and perhaps no man in the western part of the county had a wider acquaintance. He was a public spirited man, and full of energy, and there was scarcely a republican convention in the county or an old settlers' meeting that he did not attend. Although 80 years of age, Mr. Humphrey didn't look it by 10 years; no one could think of him as an aged

man, so active and energetic was he. Up to a week before his death Mr. Humphrey was active and around as usual, but on Wednesday, May 22, he was taken suddenly and seriously ill. His malady was so violent that it resembled promine poisoning Dr. G. S. Guernsey was called promptly and later Dr. McClure of Douds-Leando transferioussitusnus un hulfas ene all of no avail and May 20 her passed eway.

Greenbury B. Humphrey was born in Virginia May 12, 1827, and was at the time of his demise aged 80 years and 17 days old. His parents were David and Mary Humphrey. About the year 1837 they removed from Virginia, and after residing a short time in Ohio, they came on to Van Buren county. They were among the earliest settlers in the vicinity of Lebanon. The deceased witnessed the transformation of the wilderness into a land of prosperous and happy homes.

Mr. Humphrey was one of those hardy pioneers who, by their labor and hardship, have helped to make this county what it is today.

When a young man be made his start as a blacksmith at Lebanon. Alterwards he lived a short time at Troy. Davis county, but soon returned to Lebanon, where he conducted a general store for 37 years. Several years ago he retired from active business, but continued to manifest a keen interest in current affairs.

Feb. 13, 1851, Mr. Humphrey was united in marriage to Silena Chaffee. To them were born eight children. five sons and three daughters, three of whom passed away in infancy. Those who remain are Mrs. Elora Ann Park, of California; Mrs. Mary Cooper of Oklahoma; Mrs. Ida Prather of Ottumwa; and Silas and Edgar of Lebanon. There are also 16 grand children and 12 great grand children

The funeral services were held at the Methodist church at Lebanon on Friday, May 31, being conducted by Rev. H. F. Gilbert, assisted by Rev. Mr. McClure. The attendance at the funeral was very large.

All the children were present except Mrs. Park of California. There were also present an aged sister of the deceased, a Mrs. Wolff of Libertyville, Ia., and an only brother of the deceased's wife, a Mr. Chaffee of Marshalltown.

We give a portrait of the deceased that his many friends and acquain-tances in life man look upon the genial kindly face of their friend once more. Deceased was honorabe, hospitable, and sociable, and as one of the the small number of pioneers, he will be greatly missed.
