W. C. Schuster Dies at Age 61

PILOT GROVE—William Oletus Schuster, age 61, lifelong resident of Pilot Grove, died Sunday at St. Joseph hospital, Boonville, after after an illness of several years.

Funeral services will be at 9:30 a.m. Tuesday at St. Joseph Catholic church in Pilot Grove, the Rev. Msgr. Hagedorn officiating.

The rosary will be said at 8 tonight at the Hays and Painter chapel in Pilot Grove.

Mr. Schuster is survived by two daughters, Mrs. Mary Ann Kempf and Mrs. Jane Koosse, of Boonville; one brother, Hubert Schuster, of Pilot Grove; eight sisters, Mrs. Grace Quinlan, Mrs. Nellie Lammers, Mrs. Florence Lammers, Mrs. Catherine Bock and Mrs. Irene Schweltzer of Pilot Grove, Mrs. Alice Frederik of Boonville, Mrs. Alma Lammets and Miss Martha Schuster of Kansas City; two step-brothers, John and Fred Schuster of Pilot Grove; four step-sisters, Mrs. Sophia Lammers and Mrs. Anna Miller of Pilot Grove, Mrs. Leona Meyer of California, Mo., and Mrs. Tina Whitman of Marshall; and ten grandchildren.

Mr. Schuster was born March 3, 1900, in Pilot Grove, the son of William and Anna Vollrath Schuster. He was married Feb. 14, 1929, to Olive McCarty who preceded him in death.

One Hospitalized In U.S. 40 Crash

A two-car crash just east of the junctions of Highways 40 and 5 west of Boonville Sunday afternoon brought injuries to two persons.

Mrs. Lawrence Meekins, 31, Kansas City, a passenger in one of the cars, was taken to St. Joseph hospital where she reportedly spent a "good" night. Another passenger in the same car, Burley Maddix, 26, was treated at the hospital for minor injuries and released.

The two were passengers in a car driven by Willie Maddix Jr., Kansas City. Maddix, going west on Highway 40 attempted a left turn into a service station and struck a car being driven east on Highway 40 by Raymond D. Martin, 39, of Syracuse, N.Y. Martin estimated damage to his car at \$900. Damage to the Maddix car was about \$400.

Maddix was issued a summons for failure to yield the right-of-way by State Highway Patrolman George Grazier of Columbia, who investigated the accident.
