Missouri public assistance payments to Howard Sountians during July totaled approximately \$1000 more than in June even though there was one less recipient. The increase in disbursements results from an increase authorized by the last legislature, which became effective July 15.

There were 587 Howard Countians who received \$46,239 through the state assistance programs during July. The 146 clients of old age assistance received \$31,160. Aid to the blind amounting to \$1820 was paid to 20 persons. Aid to the permanently and totally disabled in the amount of \$4,986 was received by 58 persons.

Twenty-nine families, including 32 persons, received \$1731 in general relief. Aid to dependent children in the
